IPCC TO RELEASE STATISTICAL REPORT 2007

In 2007, a total of 2,509 complaint cases were endorsed by the Independent Police Complaints Council (IPCC). This comprised 4,341 allegations, among which, 1,182 were fully investigated. Of the fully investigated allegations, 36 were classified as 'Substantiated', 64 as 'Substantiated Other Than Reported', 5 as 'Not Fully Substantiated'. The substantiation rate in respect of fully investigated allegations was 8.9%. It must be emphasized that substantiating a complaint requires ample evidence or clear convincing justifications. Therefore, the substantiation rate should not be regarded as a yardstick in assessing the conduct of police officers or the overall effectiveness of the police complaints system.

The three major areas of complaints against the Police in 2007 in descending order, were 'Neglect of Duty' (1,551 or 35.7%), 'Misconduct/ Improper Manner/ Offensive Language' (1,539 or 35.5%) and 'Assault' (587 or 13.5%).

IPCC is primarily concerned with the comprehensiveness and impartiality of the investigations carried out by the Complaints Against Police Office (CAPO). A total of 1,700 queries/suggestions were raised by IPCC with CAPO in connection with the cases endorsed in 2007, among which, 1,205 (70.9%) were accepted and 495 (29.1%) were met with satisfactory explanations by CAPO.
