Please note the following arrangements for the IPCC Open Meetings during inclement weather:-

Meetings would continue to be held when Tropical Cyclone Warning Signal No. 1 or No. 3 is hoisted, or Amber or Red Rainstorm Warning is issued

An open meeting would be cancelled if, within two hours before the scheduled time of the meeting, it is known that a No. 8 (ii) or higher Tropical Cyclone Warning Signal or a Black Rainstorm Warning will be issued soon or is in force. The Secretary-General would arrange another meeting date in consultation with the Chairman.

If, during an open meeting, No. 8 or higher Tropical Cyclone Warning is hoisted, or Black Rainstorm Warning is issued, or it is known that a No. 8 or higher Tropical Cyclone Warning Signal or a Black Rainstorm Warning will be issued soon, the Member presiding at the meeting would decide whether to adjourn or continue with the meeting.

The Member presiding at the meeting would decide whether to adjourn or continue with the meeting if other unforeseen (iv) circumstances arise.
