## IPCC released its 2022/23 Report

(HONG KONG - 13 December 2023) The Independent Police Complaints Council (IPCC) yesterday held a media briefing to publish its 14<sup>th</sup> Report since becoming a statutory body.

During the 2022/23 reporting period, the IPCC received investigation reports from the Complaints Against Police Office (CAPO) on 1,413 new Reportable Complaint cases, representing a year-on-year decrease of 11.1%. During the same period, the IPCC endorsed 1,419 Reportable Complaint cases, representing a yearon-year decrease of 16.8%.

The endorsed Reportable Complaint cases involved a total of 2,218 allegations, representing a year-on-year decrease of 19.3%. Nearly 90% of the allegations were minor in nature, involving "Neglect of Duty" (1,033 allegations, 46.6% of the total) and "Misconduct/ Improper Manner/ Offensive Language" (942 allegations, 42.5%). Ms Priscilla WONG Pui-sze, SBS, JP, Chairman of the IPCC, said, "As always, the IPCC examines each complaint strictly on the basis of fact and evidence. We believe that the overall decrease in the number of complaints last year was related to the pandemic. However, since the society returned to normalcy earlier this year, we have noticed an uptick in the number of complaints arising from daily policing duties. The IPCC will keep monitoring the complaints trend, and propose Service

Quality Improvement Initiatives (SQIIs) to the police with a view to reducing unnecessary complaints."

Over the past 14 years, the IPCC has raised more than 220 SQIIs. During the reporting period, the Council put forward a total of 19 SQIIs to the police. At the media briefing, Secretary-General Mr Daniel MUI introduced some of these SQIIs, covering the topics of traffic enforcement, handling of digital forensics evidence and others.

The Council maintains close contact with stakeholders through a wide array of channels to enhance public understanding of the work of the IPCC and the two-tier complaints system. Mr Clement CHAN Kam-wing, BBS, MH, JP, Chairman of the Publicity and Community Relations Committee of the IPCC, said, "The Council organised and took part in more than 30 outreach activities during the reporting period, reaching over 10,000 citizens, teachers, students, as well as representatives of the police, media and professional bodies. The Council also produced an educational animation for students to explain complainants' rights and responsibilities and the role and statutory functions of the IPCC."

IPCC Chairman Ms Priscilla WONG concluded, "In the coming year, the IPCC will further its educational initiatives. We also plan to visit more police formations to see how the SQIIs are put into practice and to understand the challenges faced by frontline police officers. Meanwhile, the IPCC will continue to examine each complaint impartially and meticulously. By proposing pragmatic SQIIs, the IPCC works with the police to drive changes and enhance service quality, through which the solid foundation for mutual trust and public confidence in the
