

#### 監警會在2016年3月至7月的活動 IPCC's recent activities from March to July 2016

#### 香港大學民意研究計劃進行意見調查

Public opinion survey conducted by the University of Hong Kong Public Opinion Programme (HKUPOP)





監警會今年再次委託香港大學民意研究計劃進 行公眾意見調查,以了解公眾對監警會及其職能 的認識。調查以隨機抽樣電話訪問形式進行, 並成功訪問了1,002位18歲以上的香港居民。

This year, the IPCC once again commissioned HKUPOP to conduct a public opinion survey to assess the general public's awareness of the IPCC and its duties. The survey was conducted by telephone interview on a random sample. There were 1,002 successful interviews with Hong Kong residents aged 18 or above.

A media briefing was held to release the eighteenth issue of the IPCC Newsletter. During the briefing, Mr Larry Kwok Lam-kwong (Chairman), Miss Lisa Lau Man-man (Chairman of the Publicity and Survey Committee) and Mr Daniel Mui (Deputy Secretary-General, Operations) presented highlights of the IPCC's latest publicity initiatives. 

The IPCC organised two Observers sharing sessions on 23 May and 30 May. Mr Simon Ip Shing-hing, Ms Noeline Lau-Yuk-kuen, Miss Lisa Lau Man-man and Ms Ann So Lai-chun shared their own experiences and expressed their expectations of the IPCC Observers Scheme. A representative from the Hong Kong Correctional Services Department briefed the Observers on the arrangement for attending interviews at the correctional institutions. Secretariat staff then introduced some measures for improving the effectiveness of the Observers Scheme, such as optimising the e-portal. Observers also took this opportunity to exchange their experiences with CAPO representatives.



# Joint IPCC and CAPO Open meeting



是次聯席會議上,警方向監警會簡介「2016 重點交通執法項目」,報告有關佔領事件及 旺角騷亂的投訴統計數據和調查進度,並匯 報警方工作小組在檢視改善精神上無行為能 力人士處理手法的工作進度。此外,警方亦 交代了2016年5月張德江委員長訪港期間的公 眾活動區、採訪區及傳媒聯絡的安排,雙方 並就上述議題作出討論。 At a joint meeting between the IPCC and CAPO, the Police introduced the latest traffic enforcement priorities – "STEP 2016", and reported the number of complaints they had received and the progress with the complaints investigations in relation to the Occupy Movement and the Mongkok Riot. They then reported the progress of the Force Working Group on reviewing the enhancement measures in the handling of MIPs. They also addressed IPCC's concern about the arrangement of the designated public activity areas, designated press areas and media liaison during the visit of state leader Zhang Dejiang in May 2016. Two parties proceeded to discuss matters related to these topics.
