- 9. 任何人士如未能遵守上述守則或作出其他不檢行為,會議主席可指令其離開監警會處所。

IPCC Open Meeting

Rules for members of the public

Entering the venue

1. Display the entrance pass issued to you by IPCC staff at a conspicuous position.

Conduct

- 2. Behave in an orderly manner and comply with instructions given by IPCC staff for the purposes of keeping order.
- 3. Do not display any signs, slogans or banners, or wear any signs or slogans on your clothing.
- 4. After the meeting, you must follow the instructions given by IPCC staff to leave the venue quickly.
- 5. Turn off your mobile phones and pagers.
- 6. Smoking is strictly prohibited.

Photography restrictions

7. Do not use flash photography.

Recording the meeting

8. The meeting Chairman reserves the right to designate the position of the recording equipment and/ or prohibit voice and video recording.

Orders from the Chairman

9. If any person fails to follow the above rules or engages in any misconduct, the meeting Chairman may order the person in question to leave the venue immediately.
